Title: Part-Time Firefighter/EMT

#### **Definition:**

A firefighter delivers emergency medical service work, fire suppression, fire prevention, public education. The firefighter also participates in training and maintenance duties in order to maintain the readiness and function of the district.

#### Job Environment:

Work is performed during stressful, physically and mentally demanding situations including extreme temperatures, contaminated atmospheres, hazardous materials, heights, confined areas and trauma situations.

#### **Training and Equipment:**

All required testing, training, equipment and medical exams will be provided, at no cost to the employee by Granite Falls Fire District 17.

#### **Responsibilities:**

#### Emergency Services

Safely respond to emergencies as a member of a crew and carry out functions as assigned or per applicable protocol. This includes care of the sick or injured, entering hazardous atmospheres to carry out rescue, fire suppression, hazard mitigation, salvage and overhaul, public assistance calls and other duties.

#### Training

Attend drills and classes as well as carrying out individual study to attain required and/or desired competencies. Attend necessary drills and training to maintain FF-1 and EMT qualifications as required by the district training program.

#### General

Inspect, maintain and conduct minor repairs on apparatus, tools and equipment, grounds and facilities.

#### Knowledge, Skills and Abilities:

- Knowledge of the principles, practices and procedures of modern firefighting, emergency medical services and district policies and procedures.
- Ability to establish and maintain effective working relationship with other fire department employees, supervisors and the general public.
- Ability to conduct one's self in a professional manner that will not negatively impact the public's perception of the fire service while representing Granite Falls Fire District No. 17.
- Be agreeable to work required shifts, irregular hours and respond to emergency alarms when available and/or requested.

#### **Requirements:**

- 1. Age limit of 18 years by end of recruit training
- 2. Pass written and physical agility exam prior to start of recruit training
- 3. Pass oral board interview
- 4. Provide driving abstract over last 5-years with completed application
- 5. Agree to Washington State Patrol background check including criminal history
- 6. Have current Washington State drivers license and maintain insurability status under district insurance policies
- 7. Work a minimum of shifts per month as determined by the Fire District
- 8. Abide by the policies and procedures of Fire District 17
- 9. Pass a physical examination by a physician selected by the Fire District prior to start of recruit training
- 10. Remain in good physical condition
- 11. Successfully complete NFPA Firefighter 1 recruit training and Washington State EMT-Basic certification (All training provided by Fire District 17)
- 12. Attend firefighting and emergency medical training sessions to build and maintain skills
- 13. Possess high school diploma or G.E.D. equivalency
- 14. A minimum commitment of two years service is required with Fire District 17

## **Part-time Application Process**

1. Applications must be returned to Fire District #17, station 87 located at 116 S. Granite Ave. Granite Falls, Washington. Between the hours of 8 am to 5 pm Monday through Friday. Your application must include a "Driving Abstract" for the last 5 years, if applicable. *Driving abstracts may be obtained at any Department of Licensing.* 

### **Part-Time Application Requirements**

Complete applications must be turned in with the following documents:

- 1. Drivers Abstract.
- 2. Notarized waiver and authorization to release information.
- 3. Photocopy of current drivers license.
- 4. Photocopy of high school diploma or GED.
- 5. Immunizations records.

Lateral applicants must also include the following:

- 1. Photocopy of IFSAC Firefighter 1 Certification.
- 2. Photocopy of Washington State EMT Certification.
- 3. CPAT certification (if current within the last 12 months)
- 4. All other related training certificates.
